## **The quality and standards of the early years provision**

### **The provision does not meet requirements**

- The childminder has not sufficiently reviewed her risk assessment procedures following an incident. She has not fully considered the adult to child ratios on school collections and this potentially jeopardises children's safety.
  - The childminder has not maintained a paediatric first aid training certificate to ensure that she meets children's health and safety needs.
  - The childminder lacks up-to-date knowledge and understanding of the learning and development requirements as set out in the Statutory Framework for the Early Years Foundation Stage, therefore children's progress in learning is not monitored.
  - The childminder is not providing parents with a written summary assessment of children's progress at the age of two years which is a breach of requirement and hinders children's progress.

- The childminder supports some learning and development through daily interaction with the children and by following regular everyday routines to increase their awareness and understanding.
  - The childminder has established clear rules and boundaries to encourage and develop children's positive behaviour and to maintain their well being.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## Inspection activities

- The inspector explained the process of carrying out an inspection when no children are present.
- The inspector viewed the areas of the premises used by children.
- The inspector discussed the concerns raised and viewed a range of documentation.
- The inspector explained the outcomes of the inspection.

## Full report

### Information about the setting

The childminder registered in 1990. She lives with her husband and two adult children in the Goring area of Worthing in West Sussex. The family has several tortoises. Children remain on the ground floor of the family home with access to a secure rear garden. They use the dining room, the sitting room and the conservatory. There is a ground floor toilet. The childminder is registered on the Early Years Register and on the compulsory and voluntary parts of the Childcare Register. There are currently 14 children on roll; of these, six children are in the early years age group. The childminder also offers care to children aged over eight years and she regularly collects children from local schools. There were no children present during the inspection.

### What the setting needs to do to improve further

**To meet the requirements of the Early Years Foundation Stage the provider must:**

- ensure a current paediatric first aid training certificate is maintained at all times
- review the system for assessing risks and hazards for children on outings and minimise these by considering the adult to child ratios during school collection times
- improve your knowledge and understanding of the learning and development requirements of the Statutory Framework for the Early Years Foundation Stage
- provide parents with a written summary of their child's development in the prime areas between the ages of two and three years old

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
