## The provision meets requirements

- The childminder has a good understanding of safeguarding and child protection procedures. She knows how to keep children safe and secure.
- The childminder recognises the importance of working in partnership with parents and keeping them informed about their children's progress.
- The childminder has a good understanding of how to use observations and assessments to evaluate children's progress and to plan next steps to optimise their learning.
- The childminder demonstrates that she is able to support children to develop an understanding of the importance of physical exercise and a healthy diet.
- Information is effectively shared with other relevant professionals to ensure children's needs are consistently met and any early intervention is appropriately sought.
- The childminder's home is welcoming and toys are easily accessible to encourage children to make independent choices about their play.
- The childminder is enthusiastic and committed to providing a good quality service. She demonstrates how she works with parents and other professionals to evaluate the service she provides, and therefore, plan for improvements.

#### Information about this inspection

Inspections of registered early years provision are:

- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

#### **Inspection activities**

- The inspector took account of the resources, both indoors and outdoors and considered the plans made for weekly activities and routines.
- The inspector sampled policies and procedures, and looked at children's assessment
- records and planning documentation, discussed qualifications and training and verified that suitability checks have been completed.
  - The inspector discussed the childminder's self-evaluation form and improvement
- plan, and took account of the views of parents and carers spoken to and from written feedback included in the setting's own parent surveys.

## Information about the setting

The childminder was registered in 2008 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her two children aged nine and 13 years in a house in Speke. The whole of the house, with the exception of the bedrooms, and the front and rear gardens are used for childminding. The childminder attends a playgroup most mornings. There are currently three children on roll, all of whom are in the early years age group and attend for a variety of sessions. The childminder operates all year round, offering flexible weekday hours from 7.30am to 6pm, except bank holidays and family holidays. She is a member of the Professional Association for Childcare and Early Years. There were no children present at the time of the inspection.

#### Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
