## This inspection

This home was judged good at the last full inspection. At this interim inspection Ofsted judge that it has **sustained effectiveness**.

This inspection was carried out to assess the progress the home has made in meeting the recommendations made at the last inspection and to evaluate the experiences and progress of the young people living in the home.

The two recommendations made at the last inspection have both been addressed. This means that relationships with neighbours have improved and there have been no further complaints made by them. It has also meant that staff who are in their probationary period receive regular supervision; this ensures that they are supported effectively to carry out their roles.

The home plans well for the admissions of a young person. Needs and compatibility assessments are carried out to ensure that their needs can be met by the staff and that they will fit in with the current group of young people. Independence planning and support to young people to learn the skills they will need to live independently has led to some young people moving on successfully from the home into independent living arrangements.

Social workers working with young people are positive about their progress. One social worker said she was very happy with the way the home is working with the young person and with her. This young person has not lived in the home for long but the social worker feels that staff have taken on board his needs and are meeting these well. For example, there have been improvements in the young person engaging in work to consider his educational placement. The home works well with other agencies to support young people who offend. Young people have built up positive relationships with staff and develop respect for them. A social worker called this 'brilliant' and is hopeful for the young person's future.

Staff are committed to supporting young people to grow and develop into useful

members of society. They are concerned for their welfare and support them to learn about the risks they put themselves in through going missing or being absent. Behaviour management strategies are overall effective and are underpinned by comprehensive behaviour management plans. There remain low levels of restraints and sanctions and this indicates that behaviour management plans are effective. However, records of restraint are maintained in a form that could be tampered with.

The home is managed well overall and this is reflected in the progress that young people make. However, while the management know the strengths and areas of weaknesses the monitoring arrangements are limited to assessing that regulations and standards are met. This means that there is little focus on driving improvements to improve the overall effectiveness of the home. The monitoring reports submitted to Ofsted from the independent visitor and the manager do not include consultation with young people, their parents or their social workers. This means that these important views are not gained to further shape and develop the services.

Staff are well supported to carry out their roles and have their training needs met well. The team consists of staff who know the young people well.

This privately owned children's home provides care and accommodation for two young people with emotional or behavioural difficulties.
