Monitoring for provision judged as inadequate

An Ofsted inspector, Esther Gray, monitored your provision on 28/08/2014 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 24/03/2014, we sent you a welfare requirements notice. If you were set actions at the inspection, or as a result of our subsequent monitoring or investigations, these are included at the end of this letter.

During the monitoring visit on 28 August 2014, the inspector discussed the progress you had made and the steps you had taken to improve the quality of care and education, since the inspection carried out on 24 March 2014 and the subsequent monitoring visit on 12 May 2014. The inspector spoke to practitioners in each room, observed them interacting with children and observed the improvements made to the environment. The inspector also viewed records of children's attendance and the revised risk assessment documents staff use to ensure children are cared for in a safe environment. She also considered the steps taken to assemble all required records and put them in order. The inspector reviewed your written response to the actions raised and followed up the progress made by members of the newly-formed committee, to complete all checking processes required of them, so they can be approved as suitable for that role.

The inspector found that having taken immediate steps to regain proper control of the records, after a period of change of the overseeing committee, you had revised the risk assessment documents and the recording systems for children's attendance. You are setting about ensuring those records are now assembled and put into proper order to safeguard children and ensure the safe and efficient management of the setting, which includes the recruitment procedures. However, the record of children's attendance has not been diligently completed, and gaps in the records leave children at risk in the event of any emergency. It is not clear from the records who is responsible for their care throughout the day and not always clear when they went





home and with whom. Although some of the newly-convened committee members have successfully completed the necessary checks, using the Ofsted online system, there are others who have not, and the committee has not yet confirmed who will become the nominated person to represent this body with Ofsted.

There have been improvements in the diligence with which staff complete other records, such as the records you require within your procedures for monitoring sleeping children. These were found to be completed. Your written response to the notices identifies action taken to improve the learning environment, resources and routines that promote children's emotional and physical well-being and their independent skills. This improvement is being sustained; however, the reduced numbers of children present over the summer period means that the continuity of care for children could not be demonstrated. Practitioners who normally work with pre-school children were being utilised in the baby and toddler areas, and the practitioner who normally works with the baby and toddler children was designated to care for a mixed age range of children who were attending the holiday play scheme.

The inspector found that you have addressed the risks listed on the notice to improve, which were identified during the inspection, and the additional risk identified at the monitoring visit. This was with particular reference to children's safety gates, broken radiator covers and the exits leading onto an area adjoining the next building. Action has been taken to improve the risk assessment procedures and attempts made to implement these procedures to ensure hazards to children are kept to a minimum. However, although you had taken steps to address the risks identified at the inspection and the monitoring visit on 12 May 2014, the inspector found additional risks in the outdoor area which had not been identified and addressed in advance of children playing outdoors. This shows that risk assessment processes are still not fully effective. Consequently, you have not taken sufficient action to comply with the welfare requirement notice, and children remain at risk of harm.

Although you have reacted positively to the risks pointed out to you by the inspector, you have not demonstrated a thorough understanding of what might pose a risk to children's safety and proactively checked all areas and identified all and any risks before children are admitted to the provision. This is despite being given extra time to complete the required actions. Furthermore the registered body/committee has still not met the requirement to ensure all those responsible for the setting have been properly checked and have not demonstrated that they understand and have committed to their roles and responsibilities fully. In particular, they do not effectively oversee the manager and staff in checking and ensuring the environment is safe and suitable for children.



Having considered all the evidence, the inspector is of the opinion that the setting has not taken prompt and effective action to address the points for improvement.

Next steps

The next step will be further monitoring.
