## The quality and standards of the early years provision

### The provision meets requirements

- Staff have an understanding of safeguarding children. They demonstrate how they ensure children's safety by appropriate supervision and risk assessing the areas children use. Staff know the procedures to follow if they have concerns about a child.
- Children's health is promoted well. Staff provide a range of healthy snacks and children have plenty of exercise outdoors.
- Staff show how they plan activities and include children's interests that support their continued learning.
- There is a good partnership with parents. Staff share essential information, which supports children's care and learning.
- The manager and staff demonstrate how they review practice regularly by including children in the evaluations of activities to help the setting to improve.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## Inspection activities

- The inspector observed the range of activities inside and outdoors.
- The inspector looked at systems to maintain children's records, planning documentation, evidence of suitability of staff and a range of other documentation.  
The inspector held discussions with the manager and staff regarding safeguarding practice and supporting children in the Early Years Foundation Stage who also attend school.
- The inspector reviewed the action plans which the provider has been working on.

## Full report

### Information about the setting

Top Kids @ New Valley re-registered in 2009, following a change of ownership. It is one of three clubs owned by Top Kids Club Limited. The club operates from New Valley Primary School in Purley. It has use of a kitchen and dining area and a large hall, with direct access to an outdoor play space. Access to the after school club is suitable for those who have mobility difficulties and the setting is on the ground level. Children attend from local schools and there is a mini-bus collection from Beaumont and Hayes Primary Schools. The club is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. There are currently no children on roll in the early years age group. The club also accepts children up to the age of 11. It operates Monday to Friday during the school term from 3.00pm until 6.00pm. The club supports children with special educational needs and/or disabilities and those who speak English as an additional language. Four members of staff are employed at the club, including the owner and all hold a recognised early years qualification to at least level 2.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
