The quality and standards of the early years provision

The provision meets requirements

- The management team has a secure knowledge and understanding of how children develop and master skills. They provide appropriate activities and opportunities indoors and outside to meet children's individual needs.
- The management team understands how to promote children's well-being. Children choose from a variety of healthy snacks to support their understanding of healthy lifestyles. Staff understand how to positively manage children's behaviour.
- The management team gathers information from parents and children's teachers in order to support the children's individual care and learning needs.
- The management team and all staff have knowledge of child protection procedures and understand their responsibility to protect the welfare of children in their care.
- Risk assessments are carried out each day and all areas used are secured to promote children's safety. This demonstrates the understanding of all staff in promoting children's safety and welfare.
- The management team uses regular self-evaluation to reflect upon current practice and to further improve the outcomes for children.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector and area manager toured the areas of the premises where childcare is provided.
- The inspector discussed with members of staff the activities that they will provide and the support that they intend to offer the younger children.
- The inspector looked at policies and documents the staff use when caring for children.
- The inspector discussed with the management team their self-evaluation and plans for improvement.
- The inspector checked evidence of suitability and training for all the childcare staff.

Information about the setting

Aktiva Camps at Cowley St Laurence school registered in 2014 and is one of 15 play schemes run by Aktiva Camps Limited. Cowley St Laurence Church of England Primary School is situated in Cowley in the London Borough of Hillingdon. The after-school club operates from within the school premises and has use of the school playground. The club opens from 3.15pm until 6pm. The club is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. There are currently six children attending. At the time of inspection there were no children on roll within the early years age group. The club employs two staff who hold relevant level 3 and 4 qualifications.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
