The quality and standards of the early years provision

The provision does not meet requirements

- The childminder has failed to maintain her public liability insurance; this is also a breach of the compulsory and voluntary parts of the Childcare Register.
- The childminder has a suitable understanding of how to use observation and assessment to evaluate children's progress and to plan for the next steps in their development in order to optimise their learning.
- The childminder has a suitable understanding of her role and responsibility to protect children and report any concerns that she may have to the relevant agencies. She is able to risk assess her home to identify and minimise any potential hazards. This supports her in providing a safe environment in which children can play.
- The childminder demonstrates a suitable understanding of how to support children to settle. She explains how she intends to use information gathered from parents to provide appropriate support for them when they first start in her care. The childminder also recognises the importance of working in partnership with parents and keeping them informed about their children's progress.
- The childminder understands how to promote children's well-being. She demonstrates that she will provide children with a choice of healthy snacks and daily opportunities for fresh air and exercise. She also understands how to positively manage children's behaviour.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

The inspector discussed with the childminder how she intends to deliver the

- educational programs for children and undertake observation, assessment and planning.
- The inspector looked at policies and documents the childminder will use when caring for children.
- The inspector and childminder toured the areas of the premises where childcare is to be provided.

Information about the setting

The childminder was registered in 2010 on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. The childminder holds a childcare qualification at level 3. She lives with her partner and child, aged nine years, in a house in Swinton. The whole of the ground floor and the bathroom on the first floor are used for childminding. The family has a dog and a cat as pets. The childminder intends to attend a toddler group and activities at the local children's centre with the minded children. She intends to visit the shops and park on a regular basis with children and collect them from the local schools and pre-schools. There were no early years children on roll at the time of the inspection. She operates all year round from 7am to 6pm, Monday to Friday, except bank holidays and family holidays.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

ensure that public liability insurance is in place.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
