The quality and standards of the early years provision

The provision meets requirements

- The staff have a regard for the learning and development requirements of the Early Years Foundation Stage. They use children's interests and hobbies to plan activities which complement children's learning.
- Children are able to choose from a range of activities that are fun and provide challenge. Children are also able to complete their homework while at the after school club.
- The provider has a good understanding of how to keep children safe. Policies are in place and risk assessments are conducted which ensure potential risks to children are identified and made safe. Staff have a good knowledge of child protection and understand their roles and responsibilities to safeguard children's welfare.
- The provider understands how to promote children's health and well-being and promote their good behaviour to support their well-being.
- The views of the parents and the children are important. The provider has devised questionnaires to gain their views, comments and suggestions. The provider uses these ideas to evaluate and plan for the future of the after-school club.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

provider and the staff team, including their first-aid certificates, qualifications. The inspector also viewed evidence of public liability insurance in place.

Information about the setting

The Lighthouse Club @ St James the Great is one of three clubs privately owned by the Lighthouse Children's Foundation. The after-school club registered in 1998 and operates from St James the Great Primary School, in the London Borough of Southwark. The club is open from 3.30pm to 6pm each weekday and is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. The club employs four members of staff. The manager has a level 4 qualification in childcare and two other staff hold relevant qualifications. There were no children on roll at the time of this inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
