The quality and standards of the early years provision

The provision meets requirements

- The provider has a good understanding the different teaching methods the team can use to support children's learning and progress. They plan a wide ranging programme to inspire and engage children. They plan for using the local environment to support children's interest in the natural world.
- The provider understands how to plan for individual children's needs. Observations and assessments are precise and used effectively to plan for children's next steps in learning. For example, activities planned to promote children's creativity and encourage them to use their communication and language skills in their play.
- The provider recognises that children need to feel confident about the move to school. Consequently, the team incorporate play experiences in the plans that help children to learn about school life and to develop their sense of well-being and independence skills.
- The provider uses a selection of methods to engage and involve parents in children's learning and care. The setting has a website with information and the provider sends regular emails to parents about all aspects of the nursery. This enables parents to be full participants in supporting learning at home, and this aids children's progress towards the early learning goals.
- The provider has a very good understanding of how to keep children safe in the setting. The regularly reviewed, robust policies are shared with all staff and the manager ensures they are implemented to protect children and underpin the work of the staff team.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

The inspector discussed how the provider meets the learning and development

- requirements when providing care for children, and looked at documents related to the planning and delivery of the educational programmes.
- The inspector held a meeting with the manager, who is the early years professional of the provision.
- The inspector looked at children's observation, assessment and individual planning documentation, and a range of policies including the safeguarding procedures.

The inspector checked evidence of suitability and qualifications of staff working with

 children, and discussed the provider's self-evaluation systems and improvement plans.

Information about the setting

The Kinsbourne Common Nursery and PreSchool was registered in 2012 and is on the Early Years Register. It is situated in the 9th Harpenden Scout Hut in the Kinsbourne Common area of Harpenden, Hertfordshire. The nursery serves the local area and is accessible to all children. It operates from the main hall and there is an area available for outdoor play. The nursery employs seven members of childcare staff. Of these, three hold appropriate early years qualifications at level 3 and 6, including the manager with Early Years Professional Status. The nursery opens on Tuesday during term time. Sessions are from 9.15am until 12.15pm. There are currently 42 children on role, all of whom are in the early years age group. The nursery provides funded early education for two-, three- and four-year-old children. It supports a small number of children who speak English as an additional language and children with special educational needs and/or disabilities. At the time of the inspection there were no children present. Children also attend the adjacent Kinsbourne Common Nursery and Pre-School at St Mary's Church that is owned and managed by the same provider.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
