The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good knowledge and understanding of the safeguarding and welfare requirements. This is further supported by written policies, procedures and risk assessments to ensure that children are cared for within a safe and secure environment.
- The childminder has a range of age-appropriate toys, equipment and resources to support children's all-round development. These are easily accessible, enabling children to make independent choices in their learning.
- The childminder provides a warm and welcoming environment in which to care for children. All childminding areas are kept clean to help prevent the spread of infection.
- The childminder shows a commitment to working with all parents, in order to develop strong partnerships and promote effective communication.
- The childminder has knowledge and understanding of how children learn and develop through play. She understands her role to observe and assess, in order to plan for children's next steps in learning.
- The childminder has addressed all of the actions and recommendations from the last inspection. For example, she has a current first-aid certificate in place.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector held discussions with the childminder to check her knowledge and understanding of the safeguarding and welfare requirements.
- The inspector looked at the areas used for childminding and the resources which are used to support children's learning and development.
- The inspector looked at the policies and documents the childminder uses to support her childminding provision.

Information about the setting

The childminder was registered in 2010 and is on the Early Years Register and on both the voluntary and compulsory parts of the Childcare Register. She lives with her husband and children aged six and nine years in Hartlepool. The whole of the ground floor of the property is used for childminding. There is a fully enclosed garden available for outside play. The childminder is able to take and collect children from local schools and preschools. The family has a pet dog. The childminder operates all year round from 7.30am to 6pm, Monday to Friday, except for bank holidays and family holidays. At the time of inspection, there were no children within the early years age range on roll. The childminder is a member of the Professional Association for Childcare and Early Years.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
