### **The quality and standards of the early years provision**

#### **The provision meets requirements**

- The childminder has a valid first-aid certificate and is trained to treat any minor injuries children might sustain.
- The childminder demonstrates a commitment to improving her practice and has addressed previous actions and recommendations.
- The childminder has a variety of resources and toys to meet the seven areas of learning and development.
- The childminder demonstrates a clear understanding of the statutory requirements of the Early Years Foundation Stage. She is aware of the hazards in the environment and carries out risk assessments, to keep children safe at all times.
- The childminder has a secure outside area where children can explore and investigate, planting fruit and vegetables as well as climb and ride bikes.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## Inspection activities

- The inspector looked at areas of the home used for childminding in relation to health and safety.
- The inspector discussed with the childminder, her understanding of how to assess and monitor children's progress.
- The inspector discussed with the childminder their understanding of safeguarding and sampled a range of documents, including risk assessments.
- The inspector discussed with the childminder how they would work with parents to develop positive relationships, to meet children's individual care needs.
- The inspector looked at the play resources available and discusses with the childminder how they would adapt them to meet the individual needs and stage of development of all children.

## Full report

### Information about the setting

The childminder registered in 2011. She lives with her child in Margate, Kent. The childminder uses most of the downstairs and the bathroom upstairs for childminding. There are several steps at the front and rear of the house. They have some family pets. The childminder is registered on the Early Years Register and on the compulsory and voluntary parts of the Childcare Register. There are currently no children on roll in the early years age range. She has one child on roll who is aged seven years. The childminder looks after children Monday to Friday 7am to 7pm as well as on Saturdays 8am to 6pm. They walk to local schools to take and collect children. The childminder is a member of the Professional Association for Childcare and Early Year (PACEY).

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
