Reason for inspection

This was an unannounced emergency inspection commissioned by the Department for Education because there were concerns about pupils' welfare, health and safety.

Conclusions

Procedures for ensuring pupils' welfare, health and safety are inadequate.

School leaders are not diligent in ensuring that welfare policies are up to date and that they take full regard of the latest national guidance, for example 'Keeping Children Safe in Education' and 'Working Together to Safeguard Children'.

Staff have not had adequate training in child protection. The staff member with responsibility for child protection does not have current training at a suitable level and does not have a job description that clearly outlines his responsibilities. Staff training has not been formal enough or systematic. Staff are not suitably knowledgeable about the procedures that they should follow and are not adequately aware of the latest guidance including where there may be allegations made against a member of staff.

The single central register does not show all the required information and staff files have only very limited records about what information was checked and sought during the appointment of staff.

Staff have been checked with the Disclosure and Barring Service for criminal records but it is not clear if they have been checked against the 'barred list' or 'prohibition from teaching check'.

Pupils were polite and courteous. They said they enjoyed going to school. During the inspection the behaviour observed was satisfactory though sometimes over-boisterous. Written policies to promote good behaviour are not implemented fully. The policy to prevent bullying does not include information about cyber bullying. Those pupils who met with the inspector agreed that bullying was rare. They were aware of some types of bullying but they did not know about cyber bullying. They said that they had no access to computers or mobile phones in school or at home.

Despite requests from the inspector, the school did not present any record of sanctions for serious misbehaviour. Pupils mentioned that common sanctions were additional homework, writing lines, sitting at the front of the class or 'standing up' for up to 20 minutes. Not all these sanctions are appropriate or appear in the behaviour policy.

Senior leaders are not adequately diligent on matters of general health and safety. Risk assessments are not thorough or accurate. Too many parts of the buildings are untidy, dirty and in a poor state of repair.

Arrangements for checking who is entering the school buildings are not undertaken thoroughly. There are no signs to show visitors where to go in order to register their presence. Not all the pupil attendance registers are marked appropriately at the start of the morning and afternoon sessions. Procedures for ensuring that attendance and admissions registers are fully up to date are unclear.

Arrangements for fire risk assessments and checking fire fighting appliances are adequate. Fire drills are carried out and the time taken to evacuate the buildings is recorded appropriately. The arrangements for testing portable electrical appliances (PAT) are inadequate so that pupils' health and safety is not assured.

The procedures and practices for first aid are inadequate. A suitable number of staff have first-aid training. Procedures for recording accidents are not maintained adequately. They are too sketchy, for example about letting parents or carers know about a head injury and recording that it has been done. The school sometimes administers non-prescribed medicines such as paracetamol. However, no written parental agreement, as indicated in national guidance, is sought, although the school does telephone parents and carers. Procedures to check first-aid kits around the school are not rigorous.

The school has a complex site made up of four premises. Supervision of pupils is inadequate. There are times outside lessons when pupils are left unsupervised in classrooms both individually and in small groups. During break times staff are not adequately alert to ensure that they can see what pupils are doing. Too often staff are talking in a huddle in the playground instead of moving around the premises.

Not all parts of the building are adequately maintained. Flooring in some parts of the school is in a poor state of repair and in other parts the fabric of buildings is poor. For example, plaster is falling off leaving walls in an unsuitable condition. Parts of the buildings are untidy and dirty, including some small kitchen areas and smaller teaching rooms around the school.

Early Years

The school is not meeting the Early Years Foundation Stage statutory requirements because the provision for welfare, health and safety in the school is inadequate, parts of the premises are in a poor state of repair and not clean, equipment is unhygienic and there is no suitably qualified coordinator for the Early Years Foundation Stage.

Children are encouraged to use toys and other large equipment freely in classrooms. However, this is not well enough supervised by staff and sometimes floor space becomes unsafe because toys and equipment are strewn too widely.

Compliance with regulatory requirements

The school requires improvement and must take action to meet The Education (Independent School Standards) (England) Regulations 2010 ('the Regulations'), and associated requirements

Ensure that there are arrangements made to safeguard and promote the paragraph 7

welfare of pupils at the school which have sufficient regard to guidance issued by the Secretary of State.

Ensure that the written policy to promote good behaviour among pupils sets paragraph 9 out the sanctions to be applied in the event of pupils misbehaving and ensure that the policy is implemented effectively.

Ensure that the anti-bullying strategy is comprehensive in identifying all	paragraph 10
types of bullying and is being implemented.	

Ensure that the written policy complies with all health and safety laws and is paragraph 11 implemented effectively.

Ensure that the first-aid policy is more reflective of national guidance and	paragraph 14
implemented fully.	

Ensure that staff are deployed in such a way as to ensure the proper paragraph 15 supervision of pupils.

Ensure that there is a formal record of sanctions imposed on pupils for paragraph 16 serious misbehaviour.

Ensure that records can verify that no member of staff is barred from

Ensure that the school's accommodation and facilities are maintained to a paragraph sufficient standard to ensure the health and safety and welfare of pupils as 23C far as reasonably practicable.

- Talmud Torah Yetev Lev is a strictly orthodox Jewish day school for boys aged between three and 12 years of age. The school opened in 1965. There are 762 pupils on roll. About a quarter of the pupils are in the Early Years Foundation Stage.
- It is housed in four separate buildings: three former residential buildings and one purpose-built school building.
- Nearly all boys speak Yiddish as their first language. Pupils have both Jewish (Kodesh) and secular (Chol) studies.
- The school is open six days each week, Sunday to Friday.
