Monitoring for provision judged as inadequate

An Ofsted inspector, Jo Rowley, monitored your provision on 01/10/2014 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 09/07/2014, we sent you a notice to improve. If you were set actions at the inspection, or as a result of our subsequent monitoring or investigations, these are included at the end of this letter.

During the monitoring visit, the inspector talked with you about the steps you had taken to address the actions raised in the notice to improve. She observed a range of adult-led and child-initiated activities, which you and the children were engaged in. The inspector observed children participating in role-play activities, such as preparing and cooking some toy food. The inspector noted that you are planning activities, which challenge the children, to promote their learning and development. Through the observations you now make, you are able to asses where children are in their learning. As a result, you are providing activities that are matched to the their age and stage of development.

The inspector observed the opportunities children have to develop their self-care skills, including the putting on and taking off of their shoes and coats before and after outside play. You are aware of the importance, for children, to become independent and through activity planning, you are now organising activities, such as puzzle play, to extend opportunities, which promote this. The inspector looked at the children's learning journeys and was able to see how you are reporting on the progress they are making. In addition to this, you demonstrated through discussion how this information is shared with parents, to ensure that continuity of learning is promoted.

The inspector found that you have extended the toys and resources you have to further support children with English as an additional language. There are now books for children to explore, in their home languages and you have visited the library to further extend this. As a result, your practice is now more inclusive and children are able to use their home language in their play and learning. With positive support

from the local authority you have been able to book a range of training courses in the near future to support and enhance your knowledge and understanding of the Early Years Foundation Stage.

Having considered all the evidence, the inspector is of the opinion that the childminder has taken prompt and effective action to address the points for improvement.
