The quality and standards of the early years provision

The provision meets requirements

- The provider demonstrates a sound knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage. She provides appropriate learning opportunities to meet the children's individual needs.
- The provider appropriately demonstrates how she promotes children's safety and welfare. For example, she ensures that risk assessments of the premises are carried out and reviewed regularly to promote children's safety.
- The provider gains information from parents and children's teachers, in order to support the children's individual care and learning needs throughout their time at the club.
- The provider and her staff demonstrate a good understanding of the importance of providing a warm and caring environment, to enable children to be happy and confident, and develop strong and positive relationships with them.
- The provider understands how to promote children's well-being. She demonstrates that she provides children with a choice of healthy snacks and daily opportunities for fresh air and exercise. She also understands how to positively manage children's behaviour.
- The provider and her staff have knowledge of child protection procedures and understand their responsibility to protect the welfare of the children in their care.
- The provider demonstrates a clear commitment to self-evaluation. The recommendations from the previous inspection have been addressed. This demonstrates commitment to continued improvement.
- Parents of older children who attend the club report that they are pleased with the service provided and the information shared with them by club staff. They state that their children are happy, enjoying the range of activities available and the freedom to make independent choices.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector toured the areas used by the club for caring for children, looked at a range of resources and took account of the written views of parents and carers of older children attending the club.
- The inspector sampled a range of documents, including policies and children's records. She also viewed emergency contact information, enrolment forms and written risk assessments, and checked evidence of suitability and training of the provider and suitability of other childcare staff.
- The inspector discussed aspects of the provision with the provider during the inspection, including how she intends to deliver the educational programme for young children, self-evaluation and improvement plans.

Information about the setting

Carole Quill's Kids Club was registered in 1999 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It is situated in St. Martin's and St. Mary's Church of England School in Windermere, Cumbria. It is privately owned and managed. The club serves the local area and is accessible to all children. There are enclosed areas available for outdoor play. The club employs six members of childcare staff. Of these, five hold appropriate early years qualifications at level 3 and above, including one with Qualified Teacher Status. The club opens Monday to Friday during term time. Sessions are from 8am until 9am and 3.15pm until 5.30pm. Children attend for a variety of sessions. In addition, a holiday club is provided during school holidays from 9am until 5pm, by request from parents. There are currently 27 children attending. At the time of the inspection, no early years children were on roll.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
