## **The quality and standards of the early years provision**

### **The provision does not meet requirements**

- The childminder has not ensured that her assistant has a current paediatric first-aid certificate to enable them to have sole care for children for short periods. This is a legal requirement of the Early Years Foundation Stage framework.
- The childminder has suitable procedures in place to promote the well-being of children. She demonstrates a secure knowledge of safeguarding procedures and ensures that risk assessments of the premises are carried out daily. The childminder also conducts detailed risk assessments for trips outside of the premises to help to ensure children's safety at all times.
- The childminder has an acceptable knowledge and understanding of the learning and development requirements. She is aware of how to use observations and assessments to plan for children's individual needs to help them to make progress.
- The childminder describes how she promotes a healthy lifestyle by providing children with healthy snacks and promoting their physical development through a range of planned activities both inside and outside the home.
- The childminder has a suitable understanding of the importance of evaluating her practice to identify areas for improvement to help to raise the quality of her provision for children.
- The childminder demonstrates how she works in partnership with parents and other settings children attend in order to provide continuity in children's care and learning.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## Inspection activities

- The inspector checked all areas of the home and garden used for childminding purposes.
- The inspector discussed with the childminder how she delivers the educational programmes for children and looked at a sample of children's learning records.
- The inspector looked at policies and documents that the childminder uses when caring for children, including evidence of training.
- The inspector discussed with the childminder her self-evaluation processes and how she plans for future development.

### Information about the setting

The childminder registered in 1995. She lives with her husband, who is registered as her assistant, and their three adult children in the London Borough of Merton. All areas of the home are used for childminding purposes. The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. At the time of inspection the childminder had no children on roll.

### What the setting needs to do to improve further

**To meet the requirements of the Early Years Foundation Stage the provider must:**

- ensure that any assistant left in sole charge of children holds a current paediatric first-aid certificate.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
