The quality and standards of the early years provision

The provision meets requirements

- The childminder knows how to encourage young children's development by providing a variety of experiences relevant to their individual learning needs which encompass all areas of learning. She understands the importance of doing this in partnership with parents and others who may be involved with the children. Consequently, she develops good relationships with parents and others.
- The premises are well maintained and provide a welcoming environment for young children. There are many good quality resources available both indoors and in the garden which offer challenges and promote development. The childminder demonstrates a confident awareness of how to promote a healthy lifestyle for young children through good hygiene, healthy eating and regular exercise.
- The childminder has a clear understanding of the learning and development and safeguarding and welfare requirements. She maintains appropriate records to support an effective service. She is conscious of all aspects of safeguarding, including ensuring that children are always supervised appropriately both in the home and on outings.
- The childminder understands the importance of evaluating her practice to drive improvement in the quality of the provision for children.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

The childminder registered in 1997. She lives with her husband in a three-bedroom house, in Brighton Hill, Basingstoke in Hampshire. Children use the ground floor of the home for play, the upstairs bedrooms for rest and there is an enclosed garden for outside play. A downstairs toilet and hand washing facilities are available. The childminder lives within walking distance of local amenities. The childminder is registered on the Early Years Register and on the voluntary and compulsory parts of the Childcare Register. She currently has no children in the early years age range on roll. The family has two cats.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
