The quality and standards of the early years provision

The provision does not meet requirements

- The childminder is not complying with all of the safeguarding and welfare requirements of the Early Years Foundation Stage and Childcare Register because she does not hold a valid first-aid qualification.
- The childminder demonstrates through discussion an understanding of the learning and development requirements and her role in providing a stimulating learning environment for the children she cares for. She maintains a wide range of equipment to support children's learning and development.
- The childminder has a suitable awareness of child protection issues and the safeguarding procedures to follow in the event of concerns about a child. She has updated her policy and it is in line with requirements.
- The childminder understands how to promote children's health, safety and well-being and work with parents to meet each child's needs.
- The childminder demonstrates an understanding of her strengths and areas for development. She has completed all of the recommendations and actions made at her last inspection. The childminder has completed a number of training courses to develop her knowledge and practice to support her improvement.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had discussions with the childminder relating to her practice.
- The inspector looked at areas of the premises used for childminding and sampled relevant documentation.
- The inspector observed the children's resources and discussed activities the childminder provides to children when minding.

Information about the setting

The childminder registered in 2007. She lives in a second floor split-level flat with her three school-age children. The premises are situated in Pimlico, located in the London Borough of Westminster. The first floor lounge and second floor bathroom are used for childminding purposes.

The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. Currently there are no children on roll within the early years age range and no children were present during the inspection. The childminder offers care Monday to Friday all year round.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- complete a paediatric first-aid course relevant for workers caring for young children, and, where relevant, babies

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
