The quality and standards of the early years provision

The provision meets requirements

- The childminder has a sufficient knowledge and understanding of child protection procedures and of her responsibility to protect the welfare of the children in her care.
- The childminder understands how to keep children safe. She completes risk assessments for her home, outings and for individual children. This means appropriate safety precautions are in place to minimise the risk of accidents and injury for children.
- The childminder holds public liability insurance and a current first-aid certificate.
- The childminder has a varied selection of safe and age-appropriate resources that cover all areas of learning. She organises these around the learning environment so that children can independently make their own choices in play.
- The childminder demonstrates a sound understanding of the importance of observation and assessment. She understands how to use this information to plan challenging activities to meet children's individual learning needs.
- The childminder gathers information from parents about children's care routines, likes and progress during initial visits. She uses this information to help children settle in her care, such as providing resources that she knows children enjoy playing with.
- The childminder is aware of the importance of working with parents and other professionals involved in children's care and learning. This contributes to providing additional support and agreeing targets to meet children's individual needs.
- The childminder understands how to promote children's well-being. She discusses how she uses her garden and regular outings so that children can be active and have daily opportunities to play in the fresh air.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector and childminder toured the areas of the home where childcare is to be provided.
- The inspector and the childminder discussed and looked at toys, books, resources and equipment that she intends to use.
- The inspector discussed with the childminder how she intends to deliver the educational programme for children.
- The inspector looked at and discussed policies and documents the childminder will use when caring for children. She discussed self-evaluation and improvement plans.
- The inspector checked evidence of the suitability and training of the childminder and suitability of other household members.

Information about the setting

The childminder was registered in 1997 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and adult daughter in a house in High Green, Sheffield. The whole of the ground floor and garden are used for childminding. The childminder attends a toddler group and activities at the local children's centre. She visits the shops, park and other places of interest with children on a regular basis. She collects children from the local schools, nursery and preschools. There are currently no children on roll. The childminder operates term time only from 7am to 6pm, three days per week. The days she operates is flexible dependent on the needs of the family.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
