## The quality and standards of the early years provision

## The provision meets requirements

- The childminder has sound systems for observing, assessing and planning to meet the needs of children. She is aware of the importance of working closely with parents, agencies and other settings to help to support children's learning and development.
- The childminder has a wide range of challenging and suitable toys and resources that she uses to help promote children's learning. She makes the home visually interesting for children with a variety of posters and pictures.
- The childminder has completed safeguarding training and has a sound understanding of how to promote children's safety and welfare. She is aware of how to risk assess her home and take the necessary action to minimise hazards so that children stay safe.
- The childminder promotes children's health by providing healthy meals and snacks that meet children's dietary needs.
- The childminder has suitable systems for reflecting on her practices and identifying areas for development in order to improve outcomes for children.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## **Inspection activities**

- The inspector discussed with the childminder how she delivers the educational programmes for children.
- The inspector sampled relevant documentation and records that the childminder uses when caring for children.
- The inspector looked around the areas of the home used for children and discussed safety with the childminder.
- The inspector discussed with the childminder how she evaluates and improves her practices.

# Information about the setting

The childminder registered in 2009. She has a recognised childcare qualification at level 3. She lives with her school-age child in a first floor flat in Brighton, East Sussex near to schools, parks and shops. The majority of the property is used for childminding. There is no outdoor area so the childminder takes children out to local parks and the beach on a daily basis. There are stairs up to, and in, the flat. The childminder has a rabbit.

The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. There are no children currently on roll in the early years age range.

#### Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
