The quality and standards of the early years provision

The provision meets requirements

- The childminder has a suitable awareness of child-protection procedures and the possible signs that would raise concerns about a child's welfare.
- The childminder understands the need for risk assessment of her premises and outings to keep children safe. She holds a current paediatric first-aid certificate.
- The childminder has a suitable knowledge and understanding of how children learn and develop. She has appropriate resources and good systems to plan appropriate activities to meet children's individual needs and monitor their progress across all seven areas of learning.
- The childminder understands the importance of working in partnership with parents.
- The childminder knows how to manage children's behaviour.
- The childminder understands the importance of evaluating her provision to ensure ongoing improvements in order to promote children's progress effectively.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector looked at the areas of the childminder's home available for childminding along with resources and equipment.
- The inspector discussed the childminder's policies and documents her self-evaluation methods.
- The inspector discussed with the childminder how she plans to deliver the educational programmes for children.
- The inspector checked evidence of the childminder's suitability to be a childminder.

The childminder registered in 2000. She lives with her husband and three adult children. They live in a house in South Croydon in the London Borough of Croydon. The home is close to shops, parks, schools and public transport links. Children have access to the main living room and a games room. There is an enclosed garden for outside play. The childminder has a dog and a cat. The childminder is registered on the Early Years Register and compulsory and voluntary parts of the Childcare Register. There are currently no children on roll. She offers overnight care to children aged over five years to 11 years. The childminder collects children from the local school.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
