The quality and standards of the early years provision

The provision does not meet requirements

- The childminder has failed to maintain legally required public liability insurance.
- The childminder understands the learning and development requirements, including undertaking a progress check for children aged between two and three years. As a result, effective assessments and planning are in place to help meet individual children's needs.
- The childminder organises resources effectively to allow children to help themselves and make their own decisions and choices in their play. For example, low level equipment allows babies and younger children to explore and investigate their world.
- The childminder is aware of the importance of working with parents, carers and other professionals and describes how this helps to establish children's individual needs and ensure a consistent approach is developed between all groups.
- The childminder understands how to meet the requirements of the Early Years Foundation Stage. He demonstrates a secure understanding of his safeguarding policies and practice to ensure that children are effectively safeguarded.
- The childminder demonstrates how he monitors and evaluates the quality of his provision in order to continue to improve practice. He is pro-active in seeking support from childminder forum meetings and training.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how he intends to deliver the educational programme to children.
- The inspector looked at policies and documents the childminder will use when caring for children.
- The inspector observed areas to be used for the care of children, together with equipment and toys to be used when childminding.
- The inspector checked evidence of suitability and training of the childminder and suitability of other members of the household.

Information about the setting

The childminder was registered in 2011 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. He lives with his wife in a house in Kidsgrove, Stoke-on-Trent. The childminder co-minds with his wife, who is also a registered childminder. The whole of the ground floor and the rear garden are used for childminding. The family has cats as pets. He operates all year round from 7am to 6pm, Monday to Friday, except bank holidays and family holidays. There were no children on roll at the time of the inspection.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure that public liability insurance is in place.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
