The quality and standards of the early years provision

The provision meets requirements

- The childminder clearly understands her responsibility to safeguard children. Risk assessments are regularly reviewed to promote children's safety and well-being.
- The childminder demonstrates a secure knowledge of how young children learn and develop at different rates. Through discussion, she clearly articulates how planning will take account of the learning styles and preferences for each child so that activities are sufficiently focused to meet their individual needs.
- The environment is suitable resourced with a range of toys and equipment to meet the needs of different age groups of children.
- The childminder demonstrates through discussion how she shares information with parents and other professionals to promote continuity in children's care and learning.
- The childminder has effective systems in place to evaluate and reflect on her practice, to identify further training needs and analyse her strengths and areas for further improvements to enhance outcomes for children.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector discussed with the childminder how she meets the learning and development requirements when caring for children.
- The inspector looked at a sample of policies, procedures and paperwork.
- The inspector observed how the childminder maintains a safe environment for children.
- The inspector discussed the childminder's self-evaluation process with the childminder.

Information about the setting

The childminder registered in 2008. She lives with her husband, in a first floor low-rise block of flats in Bedfont in the London Borough of Hounslow. Access is up one flight of stairs. The premises are situated close to public transport links, schools and shops. All areas of the flat are available for childminding with the exception of the main bedroom. There is a fully enclosed garden available for outside play. The childminder currently has no children on roll in the early years age group. The childminder is registered on the Early Years Register and on the compulsory and voluntary parts of the Childcare Register. The childminder travels by bus to a local school to take children. She attends the local toddler group and takes children to the local library and park.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
