The quality and standards of the early years provision

The provision does not meet requirements

- The childminder has a poor knowledge of the Early Years Foundation Stage requirements and self-evaluation is weak. She does not have the required documentation and policies and procedures in place to support her practice. Consequently, she is not meeting a number of legal requirements, which also relate to the requirements of the Childcare Register.
- The childminder has not considered the safe use of mobile phones and cameras as part of robust safeguarding procedures, in order to promote children's safety and welfare.
- The childminder has little knowledge and understanding of the learning and development requirements, including how to promote the characteristics of effective teaching and learning. This has an impact on her ability to promote children's learning and carry out effective assessments. Consequently, she is unable to demonstrate how she will plan to meet each child's individual needs.
- The childminder does not have a secure knowledge of the seven areas of learning and how to shape educational programmes in all these areas. Therefore, she cannot effectively plan challenging learning opportunities for children through a mix of adult-led and child-initiated activities, or fully assess the progress they make.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

The inspector discussed with the childminder how she intends to deliver the

- educational programmes for children and undertake observation, assessment and planning.
 - The inspector checked evidence of suitability of adults living on the premises,
- considered the childminder's arrangements for self-evaluation and looked at some of the documents the childminder will use when caring for children.
- The inspector observed areas to be used for the care of children along with furniture, equipment and toys that are to be used for childminding.

Information about the setting

The childminder was registered in 1992 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and two adult children in a house in St Albans. The whole of the ground floor and the rear garden are used for childminding. The childminder attends a toddler group and activities at the local children's centre. She visits the shops and park on a regular basis. She takes children to, and collects them from the local schools and pre-schools. There are currently no children on roll. The childminder operates all year round from 7.30am to 5.30pm, Monday to Friday, except bank holidays and family holidays. She is a member of the Professional Association for Childcare and Early Years.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- improve knowledge of the Early Years Foundation Stage requirements to assist in developing, and implementing into practice, policies and procedures in order to meet all the statutory responsibilities
- ensure that the following information is available to parents: details of the provider's policies and procedures, including the procedure to be followed in the event of a parent and/or carer failing to collect a child at the appointed time, or in the event of a child going missing at, or away from, the setting
- develop a process of reflective practice to enable any weaknesses to be identified and then take action to tackle these weaknesses to assist in the continuous improvement of the setting
- ensure that the safeguarding policy and procedures include the use of mobile phones and cameras in the setting, in order to promote the welfare and safety of the children
- increase knowledge and understanding of the learning and development requirements, in order to: plan, provide and guide challenging and stimulating activities for children; ensure that ongoing assessment is able to be used effectively to help children to make the best possible progress.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
