Information about this inspection

Inspections of registered early years provision are:

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the compulsory part of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector looked at areas of the home used for child-minding in relation to health and safety.
- The inspector discussed the childminder's policies and procedures with her, including how she risk assesses the environments used by children both inside and outside.

- The inspector looked at all available documentation as part of the inspection process.

Information about the setting

The childminder registered in 2010. She lives with her family in Faversham, Kent. Most of the home is used for child-minding, with the exception of the main bedroom. There is one step into the home as well as out to the secure outside area. At present, the childminder does not have any children on roll in the early years age range. She has three children on roll who are aged seven years and above. The childminder is registered on the Early Years Register and on the compulsory part of the Childcare Register. She operates seven days a week from 7am to 8pm, all year. The childminder drops off and collects children from local schools. She also receives support from the local authority.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
