The quality and standards of the early years provision

The provision does not meet requirements

- Staff do not hold a current paediatric first-aid certificate, which means that children are not kept safe in the event of an accident. This is a breach of requirements on the Early Years Register and the Childcare Register.
- The safeguarding policy and procedure does not cover the use of mobile phones and cameras in the setting. Consequently, children are not fully safeguarded.
- The manager has acceptable plans in place to meet children's care needs on a day-to-day basis. This is because she gains an understanding of children's likes and dislikes from settling-in sessions and uses this information to tailor the support she provides.
- Staff demonstrate effective behaviour management strategies and are able to explain how to manage older children's behaviour when children in the early years age group are present.
- Staff explain how they promote children's well-being by providing nutritious snacks and drinks and offering opportunities for physical exercise.
- Staff understand how to use information gained about children to plan exciting and interesting activities, to encourage motivation and support children to make good progress.
- The manager demonstrates through discussion that she has a good understanding of the importance of working in partnership with parents and the school to make sure that the children's needs are met.
- The manager conducts risk assessments to ensure the premises are secure. All staff have suitability checks carried out, undertake risk assessments and know what to do if they have concerns about a child.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector viewed all areas accessed by the children including the outdoor environment.
- The inspector carried out an interview with the manager and looked at and discussed a range of policies and procedures.
- The inspector checked evidence of suitability and qualifications of staff working with children.
- The inspector discussed with the manager how the educational programmes would be delivered and viewed the range of toys, equipment and resources available for children within the early years age range.

Information about the setting

Big Bradley's Out of School Club was registered in 2010 and operates from a room in the Sure Start Centre on the grounds of Mount Pleasant infant school, Market Weighton. Children also have access to an enclosed outdoor play area. The club serves the immediate locality and also the surrounding areas. It opens five days a week from 7.30am to 8.50am and then from 3.30pm to 6pm. Children attend for a variety of sessions. There are currently 28 children on roll. At the time of this inspection there were no children on roll in the early years age range. The club employs four members of childcare staff. Of these, four hold appropriate early years qualifications at level 3. The club is registered on the Early Years Register and on both the voluntary and compulsory parts of the Childcare Register.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure that at least one person who has a current paediatric first-aid certificate is on the premises at all times when children are present
- ensure that safeguarding policies and procedures are implemented effectively and include the use of mobile phones and cameras in the setting.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
