The quality and standards of the early years provision

The provision meets requirements

- The childminder has a sound knowledge of the safeguarding and welfare requirements. She demonstrated an understanding of the local authorities' safeguarding policy and procedures and fully understands her responsibility to protect the welfare and well-being of children in her care.
- The childminder demonstrated a secure knowledge and understanding of the learning and development requirements. She was able to describe how she would use observations to track children's progress and plan for individual children's needs and the next steps for their learning and development.
- The childminder has a good range of resources, which cover the seven areas of learning and are age appropriate. She was able to describe how she would use her resources to promote children's learning in all areas to help them make progress towards the early learning goals.
- The childminder is keen to continue to develop her service and practice through updating her knowledge. She is keen to attend relevant training and use the knowledge she gains to improve outcomes for children.
- The childminder demonstrated an understanding of the benefits of effective partnerships with parents and other professionals to help meet children's needs.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the compulsory part of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder the learning and development requirements of the Early Years Foundation Stage, including how they intend to deliver the educational programmes for children.
- The inspector discussed how the childminder would implement the safeguarding and welfare requirements of the Early Years Foundation Stage.
- The inspector looked at a sample of the childminder's policies and procedures.

The childminder registered in 2011. She lives with family in the Barkingside area, in the London Borough of Redbridge. The through lounge is the main area used for childminding purposes. There is a garden for outdoor play. The childminder is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. She currently has no children on roll in the early years age group. The family has a dog.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
