The quality and standards of the early years provision

The provision meets requirements

- The childminder knows how to support, challenge and help extend children's learning and development. She understands the importance of providing activities that are based on children's interests and individual needs, in order to promote their good progress in all of the areas of learning.
- The childminder is fully aware of her responsibilities to implement the requirements of the Early Years Foundation Stage. She is well organised and has an extensive range of documentation in place, including detailed written policies for the safe and efficient management of the setting.
- The childminder demonstrates a good understanding of her role and responsibilities in safeguarding and protecting children. She is fully aware of the signs and symptoms of abuse and neglect and how to proceed if she suspects a child is at risk or if an allegation is made against herself.
- The childminder understands the importance of reflecting on and evaluating her practice to drive ongoing improvements. She knows to seek the views of parents and children to bring about positive changes that benefit the children.
- The childminder appropriately demonstrates how to promote children's safety and welfare. For example, she undertakes daily safety checks and has written risk assessments in place. These risk assessments ensure that her home is kept secure to promote children's safety.
- The childminder's home is warm and welcoming for children. She has organised an extensive range of high quality toys, books and equipment to support children's learning and development so that they can make independent choices about their play.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector looked at the areas of the premises used for childminding.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector checked evidence that appropriate suitability checks had been undertaken on all adults living in the household.
- The inspector and childminder discussed and looked at toys, books, resources and equipment that is used when childminding.
- The inspector looked at policies and documents the childminder will use when caring for children, and discussed self-evaluation and improvement plans.

Information about the setting

The childminder was registered in 2005 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and three children in Orford, Warrington. The whole of the ground floor and garden are used for childminding. The childminder visits the shops and park on a regular basis. She collects children from the local schools and pre-schools. The family has fish as pets. The childminder operates all year round from 7am to 6pm, Monday to Friday, except bank holidays and family holidays. There are currently four children on roll within the early years age group. At the time of the inspection, there were no children present within the early years age group. The childminder receives support from the local authority.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
