The quality and standards of the early years provision

The provision meets requirements

- The childminder has a sound knowledge of how children learn. She has thought about how to plan for individual learning, working with parents and other professionals to support children's learning and development.
- The childminder understands the importance of working closely with parents and carers to ensure that children's individual needs are met and routines followed.
- The childminder values the views and opinions of children and their families in order to help her improve her setting. Recommendations for improvement raised at the last inspection have been addressed and helped to improve practice. The childminder participates in training that builds on her knowledge and understanding.
- Policies and procedures give a detailed description of the childminder's practice and are ready to be shared with parents and carers.
- The childminder understands how to safeguard children and support their health, safety and well-being.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at policies and documents the childminder will use when caring for children in the early years age range.
- The inspector discussed with the childminder how she evaluates her setting and plans for improvement.
- The inspector checked evidence of suitability and qualifications of the childminder and others who may be with children.

Information about the setting

The childminder registered in 2009. She lives with her partner and three children in Greenhithe, Kent, close to schools, shops, parks and pre-schools. The whole of the childminder's house is available for childminding, with a fully enclosed garden for outside play. The bathroom is upstairs.

The childminder is registered on the Early Years Register and on both the voluntary and compulsory parts of the Childcare Register. There are currently no children on roll in the early years age range and no children present during the inspection. The childminder offers care to children aged over five years to 11 years.

The childminder walks and drives to local schools and pre-schools to take and collect children. She is willing to attend toddler groups. The childminder is a member of an approved childminding network. The childminder has a childcare qualification at level 3.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
