The quality and standards of the early years provision

The provision meets requirements

- The inspection was carried out as a result of a complaint to Ofsted about the suitability of the childminder. The inspection found that the childminder is suitable and is clear about her role and responsibilities.
- The childminder understands how to manage children's behaviour according to their age and understanding.
- The childminder understands the procedures to follow if she has a concern about a child. She knows what action to take if allegations are made about her or members of the household. She has a clear safeguarding policy, which includes procedures for the use of cameras and mobile phones.
- The childminder describes how she uses observations and assessments to provide children with a range of activities and experiences to promote their learning and development.
- The childminder understands the importance of having a two-way flow of communication with parents to promote children's continuity of care and learning.
- The childminder has addressed the actions and recommendations raised at the last inspection and investigation visits.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector held discussions with the childminder.
The inspector sampled documentation, including children's information records, the records of the risk assessments and observation and assessment records. She also
- looked at the childminder's training certificates, written policies and parents' questionnaires.

Information about the setting

The childminder registered in 2007. She lives with her three adult children in Chingford, in the London Borough of Waltham Forest close to public transports, schools, parks and the forest. The whole of the ground floor and the first floor bathroom of the childminder's house are used for childminding and there is a fully enclosed garden for outside play. Accessibility to the premises is via two small steps.

The childminder is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. She regularly works with an assistant. The childminder is currently caring for two children in the early years age range. There were no children present at the time of the inspection. The childminder also offers care to children aged over five years to 11 years. No children were present at the time of the inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
