The quality and standards of the early years provision

The provision meets requirements

- The childminder has a secure understanding of the Early Years Foundation Stage and how children learn. She demonstrates a clear knowledge of the observation, planning and assessment process to support individual children's progress towards the early learning goals.
- The childminder has a good understanding of her responsibility to safeguard children. This includes how to minimise risk. She is aware of the signs and symptoms of abuse and the procedures to follow should she have concerns. She maintains all the required documents and policies to promote children's safety and well-being.
- The childminder effectively demonstrates how she will reflect on her practice to improve the quality of her provision.
- The childminder understands the importance of providing a caring environment, which enables children to be comfortable in their surroundings and develop positive relationships with her.
- The childminder fully understands the importance of working in partnership with parents, and other professionals, to provide consistent care and learning to children.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector discussed with the provider how they will deliver the educational programmes and care for children.
- The inspector looked at policies and documents the provider uses when caring for children.
- The inspector discussed the provider's self-evaluation process.
- The inspector had a tour of the setting and looked at the resources and space used for children.

Information about the setting

The childminder registered in 1993 on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. The childminder lives with her husband and one adult aged child in Reading, Berkshire. The ground floor of the house is available for childminding. There is a fully enclosed garden for outside play. The family has three pet cats. The childminder has five school-age children on roll. At the time of this inspection, there were no children on roll in the early years age group. The childminder walks to local schools to take and collect children. The childminder holds a relevant childcare qualification.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
