The quality and standards of the early years provision

The provision meets requirements

- The childminder identifies through discussion, that she is aware of the Early Years Foundation Stage learning and development requirements. She explains how she plans to adapt activities, in order to challenge children and help them to make progress in all areas of their learning.
- The childminder understands the need to provide a range of resources and activities in order to meet the needs of children at different stages of development.
- The childminder demonstrates a sound understanding of appropriate behaviour management strategies to help children learn about the expectations of good behaviour.
- The childminder demonstrates how she would work in partnership with parents and understands how this helps to provide children with a continuity of care, and supports their emotional well-being.
- The childminder has developed a suitable understanding of her roles and responsibilities with regard to child protection issues. She understands the possible signs of abuse and she knows what to do if she was to have a concern about a child in her care.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector spoke with the childminder about how she will deliver educational programmes.
- The inspector held discussions with the childminder about her procedures for safeguarding children.
- The inspector checked essential documentation, including policies, procedures and registers.
- The inspector discussed with the childminder how she monitors and evaluates her practice through the use of a self-evaluation document.

Information about the setting

The childminder was registered in 1995 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her partner and adult daughter in a house on the outskirts of Leicester City. The whole of the ground floor and the rear garden are used for childminding. The family has two dogs as pets. She collects children from the local schools and pre-schools. There are currently no children on roll in the early years age group. She operates all year round from 7.30am to 6pm, Monday to Friday, except bank holidays and family holidays.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
