The quality and standards of the early years provision

The provision does not meet requirements

- The childminder has failed to notify Ofsted of changes to persons aged 16 years or older living on childminding premises. This is an offence, although on this occasion Ofsted does not intend to take any action. The childminder is in the process taking action to address this. This also means the childminder is not meeting the associated requirements of the Childcare Register.
- The childminder has limited knowledge of safeguarding procedures. For example, she is not aware of what action to take in the event of an allegation being made against adults in the household. In addition, she does not know to protect children from the use of mobile phones and cameras.
- The childminder keeps accurate records of any accidents children may have. However, she does not gain the required parental consent before giving medication she gives to children.
- The childminder has limited knowledge of her responsibilities for meeting the learning and development requirements. She has insufficient understanding of how to observe and assess children's development or how to plan activities to meet their individual learning needs.
- The childminder understands the need to provide a range of resources to suit children's differing ages and interests. She is able to provide healthy foods to promote children's health.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the compulsory part of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector checked documentary evidence of the childminder's suitability to work with children, including her qualifications.
- The inspector looked at the premises used for childminding.
- The inspector held a discussion with the childminder about the requirements of the Early Years Foundation Stage and how she meets them.

The inspector discussed the process of self-evaluation, including establishing
whether the childminder has addressed previous actions and a recommendation from the last inspection.

Information about the setting

The childminder registered in 2007. She lives with her two children and her mother in Tongham, Surrey. Most of the childminder's home is used for childminding and there is a garden for outside play. The childminder's provision operates from Monday to Friday for most of the year. The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. The childminder is able to take and collect children from local nurseries and schools. At the time of the inspection there were no children in the early years age range on roll.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- improve knowledge of safeguarding procedures in line with the Local Safeguarding Children Board procedures, including knowledge of the action to be taken in the event of an allegation being made against adults in the household, and of the safe use of mobile phones and cameras
- gain prior written parental consent to administer each individual named medication
- develop a knowledge of the learning and development requirements of the Early Years Foundation Stage in order to be able to use observations to develop precise assessments, including the required progress check for children aged two, to shape learning experiences so that children make good progress

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
