## The quality and standards of the early years provision

### The provision meets requirements

- The manager has a sound understanding of her responsibilities and meets the safeguarding and welfare requirements effectively.
- Staff offer children interesting and challenging activities to help them stay motivated and join in at the club.
- Staff have a secure knowledge of safeguarding procedures, so they can identify concerns and report these appropriately to safeguard children.
- Staff work effectively with parents by keeping them updated about their child's time at the club, so that their needs are met well.
- Staff develop their skills by undertaking further training and self-evaluating their practice, to benefit the children.
- Staff promote diversity with the children, by providing resources showing positive images of others and celebrating different cultural festivals.
- Staff work closely with the teachers at the school, so that children's individual needs are met.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector looked at the areas used by children at the club.
- The inspector discussed and viewed documentation used by the club.
- The inspector had discussions with the manager, to ascertain her understanding and knowledge of the safeguarding and welfare requirements.

## Full report

### Information about the setting

Bright Futures Kids Club (Dorothy Barley) is one of four after school clubs run by a private company. It opened in 2006 and operates from the large hall and a small information, communication and technology suite, in Dorothy Barley Infant School, in Dagenham, Essex. The out of school club is open each weekday, from 3pm to 6pm, term time only. All children have access to a secure enclosed outdoor play area. There are currently two children in the early years age group on roll, who were not present during the inspection. Children who attend are pupils from Dorothy Barley Infant and Junior Schools. The provider employs three members of staff, two of whom hold appropriate early years qualifications.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
