**The quality and standards of the early years provision**

**The provision meets requirements**

- The childminder is fully aware of the learning and development requirements. She has appropriate systems to plan for individual children's developmental needs and help them to make good progress in their learning.
- The childminder demonstrates a good understanding of safeguarding procedures. Through discussion, she shows she is aware of significant events and changes that need to be notified to Ofsted.
- The childminder demonstrates through discussion and documentation that she understands how to use risk assessments to ensure children play in a safe and healthy environment.
- Through discussion, the childminder demonstrates she would work closely with parents to ensure children have suitable settling-in opportunities to become familiar with her setting and her family.
- The childminder holds public liability insurance and has a current first-aid certificate, which promotes children's safety in the event of accidents and minor injuries.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## Inspection activities

- The inspector looked at areas of the home used for childminding and some of the resources that would be available to the children.
- A range of documentation was checked, including some policies and procedures, children's record forms and suitability checks for the childminder and her family.
- The inspector spoke with the childminder about how she would deliver the educational programme and complete the progress check for children aged between two and three years.

### Information about the setting

The childminder was registered in 2012 and lives with her family in Ely, Cambridgeshire. She is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. Minded children have use of the ground floor of the home with one bedroom on the first floor available for sleeping. There is an enclosed garden for outdoor play. The family has a goldfish as a pet. The childminder offers her childminding service each weekday during school term times. She is a member of the Professional Association for Childcare and Early Years and holds a childcare qualification at level 3. There were no early years children on roll at the time of the inspection. The childminder provides out-of-school care to older children.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
