The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good understanding of the learning and development requirements of the Early Years Foundation Stage. She has procedures in place to assist her in observing and assessing children's stages of development to inform children's next steps in learning.
- The childminder clearly describes the measures she puts in place in order to ensure children's safety and well-being within her home.
- The childminder attends regular training in order to ensure that her knowledge and skills are up to date.
- The childminder has procedures in place to support the ongoing evaluation of her work. This would include seeking the views of parents and children.
- The childminder understands the importance of working in partnership with parents and the other settings that children attend. She describes clearly the procedures she would put in place to ensure a two-way flow of communication.
- The childminder attends regular safeguarding training. She has a good knowledge of safeguarding procedures and of the steps to take in the event of a concern about a child's welfare.
- The childminder holds public liability insurance and a current paediatric first-aid certificate.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector spoke to the childminder with regard to how she will support children's learning and development, keep children safe and promote their well-being.
- The inspector reviewed documents including evidence of training, the safeguarding policy and suitability records of the adults in the household.
- The inspector discussed self-evaluation with the childminder and her plans for improvement.
- The inspector had a tour of the premises.

Information about the setting

The childminder was registered in 1988 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and adult child in a house in Cambridge. The whole of the ground floor and rear garden are used for childminding purposes. The childminder takes children to, and collects children from, the local schools and pre-schools. The childminder operates all year round from 8am to 5.30pm, Monday to Friday, except bank holidays and family holidays. She is a member of the Professional Association for Childcare and Early Years. At the time of inspection, there were no children on roll within the early years age range.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
