The quality and standards of the early years provision

The provision meets requirements

- The childminder demonstrates how she would monitor children's progress using observations and assessments. She discusses how she would use this information to plan the next steps in children's learning based on their interests.
- The areas of the home used for childminding are safe and clean for children to play. Through appropriate hygiene routines, promoting healthy eating and encouraging children to be active outdoors, the childminder encourages children to lead a healthy lifestyle.
- The childminder is knowledgeable about the documentation requirements of the Early Years Foundation Stage. She demonstrates that she has processes to appropriately gather information in relation to children's care needs, which contribute to the safe and efficient management of the setting.
- The childminder has a sound knowledge of child protection procedures approved by the Local Safeguarding Children Board. She fully understands her responsibility to protect children's welfare and can clearly demonstrate what action to take if she had a concern about a child.
- The childminder holds a current first-aid certificate and has public liability insurance. She has the knowledge and skills to meet children's needs in the event of an accident or an emergency.
- The childminder explains how she obtains information from parents to provide appropriate care for children. She is clearly aware of the benefits of successful engagement with parents and explains that important information is shared each day through verbal exchanges and the use of a daily diary with younger children.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector held discussions with the childminder to check her knowledge and
 understanding of the safeguarding and welfare requirements, and the learning and development requirements of the Early Years Foundation Stage.
- The inspector looked at the areas used for childminding and the resources, which will be used to support children's learning and development.
- The inspector looked at the policies and documents the childminder uses to support her childminding provision.
- The inspector discussed with the childminder how she monitors and evaluates her provision.
- The inspector checked details of the childminders qualifications and training and also evidence of suitability for all household members.

Information about the setting

The childminder was registered in 1996 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and three adult children in Tibshelf, Derbyshire. The whole of the ground floor except for the bedroom is used for childminding. There is a patio area and rear garden for outside play. Access to the home is via steps on the front path and to the rear door. The family has a dog as a pet. The childminder drives and walks to the local school to take and collect children. The childminder holds an early years childcare qualification at level 4. There are currently nine children on roll, none of whom are in the early years age group. They attend for a variety of sessions before and after school and during the school holidays. She operates all year round from 7am to 6pm, Monday to Friday, except bank holidays and family holidays.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
