Monitoring for provision judged as inadequate

An Ofsted inspector, Sarah Taylor, monitored your provision on 10/12/2014 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 26/12/2014, we sent you a welfare requirements notice. If you were set actions at the inspection, or as a result of our subsequent monitoring or investigations, these are included at the end of this letter.

During the monitoring visit the inspectors discussed with you the steps you have taken to address the actions raised in the Welfare Requirements Notice. The inspectors toured the premises and reviewed the planning and implementation of the key-person system. The inspectors interviewed the nominated person and reviewed staff appraisals and support systems. The inspectors also took account of the views of a representative from the local authority who is currently supporting your setting to improve.

The inspectors found that you have taken prompt and effective action by implementing a new planning system. This has helped staff to identify the next steps in children's learning and development. Furthermore, staff are now completing detailed observations which helps them to plan a wide range of suitably challenging activities. As a result, children's progress is improving steadily. Staff's knowledge and understanding of the Statutory framework for the Early Years Foundation Stage has also improved. Consequently, they are able to identify any gaps in children's development and seek any additional support that children may require. Further training on planning for the early years and promoting children's communication, along with close support from the owner and manager, has ensured that staff are now interacting well with the children.

During the visit the inspectors found that the keyperson system has been improved and staff are familiar with children's likes and dislikes. For example, staff are now





obtaining written information from parents about children's care needs which helps children to feel secure at the nursery. Staff are now liaising more effectively with outside agencies to promote a consistent approach to meeting children's individual needs. In particular those who speak English as an additional language. Children observed on the day of the visit were happy and content. For example, they readily had cuddles with staff and thoroughly enjoyed listening to a story with their keyperson.

The inspector found that the setting has ensured that the environment is now safe for children. For example, the garden fence has now been fixed in the children's outdoor play area.

The systems for managing the performance of staff are being developed. For example, the owner and manager have begun carrying out observations of staff to identify their strengths and areas to improve.

However, they are yet to complete staff appraisals and ensure that training is sharply focused on the outcomes of these.

The inspectors found that as a result of this visit, that overall you have taken prompt and effective action to meet the actions raised. As a result, the next step will be a full re-inspection.

Having considered all the evidence, the inspector is of the opinion that the setting has taken prompt and effective action to address the points for improvement.

Next steps

The next step will be a full inspection.
