The quality and standards of the early years provision

The provision meets requirements

- Parents are engaged in the club. Staff work with them closely to keep them fully informed of how the club meets their child's needs and frequently share information and ideas to further support care at home.
- The parts of the premises used for the care of children are bright, spacious and welcoming. The resources are varied and the staff demonstrate a good knowledge of how to use them to be able to engage children in interesting and challenging experiences. They plan for individual children's needs and fully understand the benefits of completing observations.
- The staff demonstrate they have a good understanding of how to promote children's good health and hygiene. All risks are identified within the environment and effectively minimised. Staff understand how to protect children in their care, including setting clear behavioural boundaries with the children for the club.
- The staff support children who have special educational needs and/or disabilities by seeking advice and support from parents and relevant professionals.
- The manager is the designated safeguarding member of staff and has ensured that all staff have sufficient knowledge of child protection procedures and are able to follow relevant guidance. The manager fully understands her responsibility to protect the welfare of the children in her care.
- Self-evaluation is focused as the staff team work together and have identified areas for continuous improvement within the provision. They intend to drive for improvements in practice by continually seeking children's and parental opinions, further training and additional resources.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector toured the areas od the premises used by the children.
 - The inspector held discussions with the manager and the staff about how they
- deliver the safeguarding and welfare requirements of the Early Years Foundation Stage for children in their care.
 - The inspector checked evidence of the suitability and the qualifications of the staff,
- sampled documentation, such as policies and procedures, and discussed the provider's self-evaluation.
- The inspector took account of the views of parents and carers spoken to on the day.

Information about the setting

Wiz Kids Out of School re-registered at new premises in 2011. It is part of Puddleducks Daycare Ltd and there is a sister daycare setting also located in Evesham. The out-of-school club is based at a sports club premises in Evesham. Children have access to a large enclosed outdoor play area. The club is open each week day for 51 weeks of the year, closing for a week at Christmas and New Year and for bank holidays. During school term time sessions are from 3pm until 6pm, and in school holidays sessions are from 8am until 6pm. The club is registered on the Early Years Register and both parts of the Childcare Register. There are currently 40 children on roll, nine of whom are in the early years age group. No early years children were present at the time of the inspection. There are four members of staff, of whom two, including the manager, hold an appropriate qualification at level 3. The club collects children from schools in and around Evesham. The club supports children with special educational needs and/or disabilities and children who speak English as an additional language.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
