The quality and standards of the early years provision

The provision does not meet requirements

- The management are in breach of requirements for the Early Years Foundation Stage and the Childcare Register. They have failed to understand their legal duties to inform Ofsted of changes to the manager and members of the committee. As a result, Ofsted has not vetted the new committee members to check their suitability. This means children's safety and welfare cannot be assured.
- Staff do not implement the club's first-aid and accident policy and procedures to promote children's well-being. They have a poor understanding of their duties to promptly inform parents and/or carers of accidents and first-aid treatment given to children.
- Staff gain appropriate information from the children's main school setting. They use this to plan suitable activities that complement the learning that takes place at school. For example, staff plan fun activities including cooking and art in relation to a school topic about creatures and living things

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector sampled documentation including written policies and procedures.
- The inspector viewed the premises and equipment to assess their suitability.
- The inspector discussed safeguarding with the staff.
- The inspector discussed the club's self-evaluation and arrangements for checking staff and committee's suitability for their role.
- The inspector spoke to children and staff present on the day of the inspection.

Information about the setting

Fabulous Fun Club opened in 2003. It operates from the community room, the hall and the outside play areas at Uphill Primary School, North Somerset. There is a cloakroom area and toilet block directly next to the community room for the children to use. The club opens five days a week during term time, from 3pm to 5.45pm. It is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. There are currently four children on roll in the early years age group. No early years children were present at the time of the inspection. There are five members of staff who work directly with the children. Three have appropriate qualifications at level 3 and one member of staff holds a qualification at level 2. There is also an administrator employed.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- implement robust systems to check all committee members suitability for their role, including gaining an enhanced Disclosure and Barring Service check
- inform parents and/or carers of any accident or injuries that have occurred to a child and of any first-aid treatment given on the same day or as soon as reasonably possible.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
