The quality and standards of the early years provision

The provision meets requirements

- Children's well-being is effectively safeguarded because the childminder has a good awareness of the signs and symptoms of abuse to help her recognise when a child may be at risk. She understands that the child is her first priority and is confident to report concerns in line with Local Safeguarding Children Board guidelines.
- The childminder shows a good understanding of the importance of working in partnership with parents and has established strong relationships with them. Written testimonials from parents show that they are pleased with the childminding service that is provided, describing the childminder as 'supportive, friendly, genuine, happy and fun'.
- The childminder demonstrates, through discussion, a good understanding of her responsibilities to support children's learning and development. She has effective methods to observe and assess children's learning, in order to plan and provide an enjoyable and challenging range of activities.
- Children are able to play safely because the childminder maintains a record of risk assessments, clearly stating risks and the steps she takes to reduce hazards. Children's well-being is further assured because the childminder maintains a paediatric first aid certificate to ensure she knows what to do in the event of an accident.
- The childminder demonstrates that she understands the benefits of reflecting on her practice, to identify the strengths of her childminding setting and areas for improvement. She seeks the views of parents and children to ensure that she is able to meet children's individual needs.
- The childminder's home is welcoming, friendly and well resourced. Toys are stored well, to enable children to select resources for themselves. This supports children's independence and sense of belonging. Effective settling-in processes for new children enable them to build close emotional bonds with her.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector checked the suitability of the rooms used for childminding.
- The inspector checked evidence of the suitability of household members.

Information about the setting

The childminder was registered in 2003 and is on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. She lives with her husband and two adult children in a house in Stanton, Suffolk. The whole of the ground floor, a bedroom on the first floor and the rear garden are used for childminding. The family has a dog as a pet. The childminder attends a toddler group and visits the shops and park on a regular basis. The childminder takes children to and collects children from local schools and pre-schools. There are currently seven children on roll, two of whom are in the early years age group and attend for a variety of sessions. At the time of this inspection there were no children present. The childminder operates all year round from 8am to 6pm, Monday to Friday, except for bank holidays and family holidays. She is a member of the Professional Association for Childcare and Early Years.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
