The quality and standards of the early years provision

The provision meets requirements

- The childminder has a suitable understanding of how to deliver the requirements of the Early Years Foundation Stage. All documentation to ensure the smooth running of her childminding service and to effectively safeguard all children is in place. In addition, the childminder holds a current first-aid certificate and maintains public liability insurance.
- The childminder demonstrates a good knowledge of how to plan stimulating activities across the seven areas of learning. She knows how to successfully complete observations and assessments to recognise and build on children's achievements and track their progress.
- The play environment is very clean and suitably resourced with a range of toys and play equipment to meet the needs of the different age groups of children.
- The childminder fully understands how to support children's health and well-being. She discusses the importance of providing children with a healthy diet and ensuring they have daily opportunities for physical play, fresh air and exercise.
- The childminder is clearly aware of the benefits of successful engagement with parents, and explains that feedback is given to share important information about children's care and learning each day.
- The childminder has established good links with local primary schools and teachers to ensure children are effectively supported as they move onto full-time education.
- The childminder thoughtfully reflects on her strengths and identifies areas for further development. She regularly consults parents and children for their views and suggestions and is receptive to advice from her network development worker. Consequently, she shows a firm commitment to continually improving the quality of her practice to enhance future opportunities for children.

Information about this inspection

Inspections of registered early years provision are:

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

The inspector discussed with the childminder how she intends to deliver the

- educational programmes for children and undertake observation, assessment and planning.
- The inspector toured the premises and viewed the play equipment.

The inspector viewed evidence of suitability and qualifications of the childminder,

- risk assessment, self-evaluation and other documentation in relation to health and safety checks.
- The inspector discussed with the childminder how she monitors her provision and develops partnerships with parents and other professionals.
- The inspector obtained the views of parents and children from their responses to surveys, or from references obtained by the childminder.

Information about the setting

The childminder was registered in 1992 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives in a bungalow in Westcliff-on-Sea, Essex. The living room, conservatory and the cabin in the rear garden are used for childminding. During the inspection, the childminder was not minding any children in the early years age group. The childminder offers care to children aged over five years to 16 years. She drives to collect children from local schools. The childminder works Monday to Friday, during school term times from 3pm to 9pm, and during school holidays from 8am to 6.30pm. She is a member of the Professional Association for Childcare and Early Years and a local childminding network.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
