The quality and standards of the early years provision

The provision meets requirements

- Leaders and managers demonstrate effective partnerships with external agencies that help to secure appropriate interventions for children to receive the support they need.

Information about this inspection

Inspections of registered early years provision are:

- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate

- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector examined documentation including a sample of children's records, policies, and staff training records used when caring for children.
- The inspector discussed with the manager the arrangements for keeping children safe.
- The inspector discussed with the manager how they intend to deliver the educational programmes for children.

Information about the setting

Wakoos Centre4Children After School club was registered in 2012. It operates from the women's hall in Billingshurst, West Sussex. Children have access to a large hall and an enclosed outside play area. The staff escort children to and from the local primary school. Sessions run from 3pm to 6pm, Monday to Friday term time only. The setting also runs a holiday club during the summer.

The setting is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. There were no early years children present at the time of the inspection. The setting also cares for children aged over eight years old. There are three members of staff, all hold relevant childcare qualifications.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
