The quality and standards of the early years provision

The provision does not meet requirements

- The provider has behaviour management strategies but does not ensure that the manager and staff understand how to implement these in an appropriate way. The requirements of the Childcare Register are not met.
- The provider does not ensure that management understand how to deploy staff to supervise children appropriately in order to maintain their safety.
- The provider knows how to provide suitable activities and a wide range of resources to cater for the different needs of children attending the club.
- The provider makes sure that management and staff know that effective partnership with parents supports children's care and development. All staff know how to make parents welcome and how to keep them informed of children's activities. Parents' views contribute to evaluating the effectiveness of the provision.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector observed the facilities and resources available for children's use indoors and outside.
- The inspector held a meeting with the manager and talked with staff.
- The inspectors checked evidence of staff suitability and qualifications to work with children and looked at other documentation.
- The inspector took account of the views of parents.

Information about the setting

Kids City Sunnyhill Road out-of-school club has been open since 2007. It operates from Sunnyhill Primary School, Streatham in the London Borough of Lambeth. The club has the use of two halls, toilet and washing facilities, and of the playground. The club is used by children who attend Sunnyhill Primary School. Children over eight years may attend. There are currently 35 children on roll aged between 3 and 11 years; five of these children are in the early years age group, but none of these early years children were present at this inspection. The club opens each week day from 3.15pm until 6pm during school term times. A team of three members of staff, including the centre manager work with the children. There are a number of volunteers who work on different days of the week. Three staff hold suitable recognised qualifications. The club is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure staff understand how to manage different types of behaviour children's behaviour appropriately
- ensure that management understands how to deployed staff suitably to keep children appropriately supervised and minimise risks to their safety

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
