The quality and standards of the early years provision

The provision meets requirements

- The premises are safe and secure. The childminder carries out regular risk assessments indoors and outdoors to identify and reduce potential hazards to children. All mandatory records required for the safe management of children are in place. This guides the childminder in her daily practice to promote children's welfare.
- The childminder understands child protection issues and the procedures to follow if she has a concern about the well-being of a child.
- The childminder understands the need to plan activities, and provide age-appropriate resources, to help children to make progress in all areas of learning.
- The childminder manages children's behaviour through simple explanation to help them understand why certain behaviour is not acceptable.
- The childminder understands the importance of working in partnership with parents to help ensure that children's individual needs are met.
- The childminder has addressed the recommendations set at the last inspection. She strives to continuously improve outcomes for children through self-evaluation and attending training to develop her knowledge and skills further.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Information about the setting

The childminder was registered in 2002. She lives with her daughter in the South Woodford area of the London Borough of Redbridge. The ground floor of the childminder's home is used for childminding purposes. An enclosed garden is available for outdoor play.

The childminder is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. There were no children in the early years age range on roll at the time of the inspection. The childminder is currently looking after children in the later years age group during, before and after school hours. The childminder holds an NVQ level 4 qualification in Early Years Practice.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
