The quality and standards of the early years provision

The provision does not meet requirements

- The childminder has not kept up to date with the safeguarding and welfare, and learning and development requirements of the Early Years Foundation Stage. She does not have a valid first-aid certificate and this is a breach of requirements.
- The childminder has a suitable range of toys and resources that cover all areas of learning. However, she has little knowledge of the learning and development requirements and, therefore, is unable to demonstrate how she would use these to help children make progress.
- The childminder's understanding of how to self-evaluate her practice is not secure enough to identify and address key weaknesses in practice.
- The childminder's home is safe and secure. She has a sound awareness of the safeguarding procedures she would follow if she was concerned about a child. However, she does not have a written safeguarding policy or a written complaints procedure. These are breaches of the Childcare Register requirements.
- The childminder demonstrates a suitable knowledge of how to promote children's good behaviour.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector discussed with the childminder how she would deliver the educational programmes for children.
- The inspector discussed the childminder's policies and procedures.
- The inspector discussed self-evaluation and continuous improvement with the childminder.

Information about the setting

The childminder registered in 1986. She lives with her husband in Hayes, in the London Borough of Hillingdon. The childminder uses most rooms in her home for childminding purposes and there is a fully enclosed garden for outdoor play. There are currently no children on roll. The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- maintain a current paediatric first-aid certificate
- improve knowledge of the revised Early Years Foundation Stage learning and development requirements, to include the seven areas of learning and the assessment requirements.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
