The provision meets requirements

- The childminder knows how to organise the premises to provide children with a wide range of resources both inside and outside.
- The childminder understands the importance of working in partnership with parents, other early years providers and outside agencies to provide a consistent approach to children's learning and care.
- The childminder knows how to support children learning English as an additional language and how to promote equal opportunities for children.
- The childminder has a suitable awareness of the importance of reflecting on her practice and using self-evaluation to make continuous improvements.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector discussed with the childminder how she plans to organise her premises, equipment and resources for childminding.

Information about the setting

The childminder registered in 2006. She lives with her two teenage daughters in Highbridge, Somerset. The childminder mainly uses the ground floor of her premises for childminding. There is an enclosed rear garden with a covered patio for outdoor play. The childminder is registered on the Early Years Register, and the compulsory and voluntary parts of the Childcare Register. She currently has no children on roll in the early years age group. The childminder also offers out-of-school care to older children. She walks, or drives, to pick up and drop off children from the local schools. The family has cats and dogs as pets.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
