The quality and standards of the early years provision

The provision meets requirements

- The childminder has an awareness of the statutory requirements of the Early years Foundation stage, to support children's welfare and development.
- The childminder uses an effective range of systems to support and promote children's learning, and implements a range of policies to support children's health and safeguard them.
- The childminder takes effective steps to review the service she offers. She has addressed recommendations from the previous inspection, gained a level three qualification, joined a quality assurance scheme, and sought feedback from parents about the service they and their child receive.
- The childminder works with a professional approach to engage parents to support their child's learning and development. She maintains links with other professionals and settings that a child may also attend.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector held discussions with the childminder to explore her understanding of the learning and development requirements, and the safeguarding and welfare requirements.
- The inspector looked at the records maintained by the childminder to monitor children's learning and developmental progress.
- The inspector looked at a sample of required records maintained by the childminder, and the range of policies and procedures she shares with parents.
- The inspector held discussions and looked at some of the systems the childminder uses for self-development, and for improving the service she offers.
- The inspector looked at areas of the home used for childminding, and a sample of the play materials she offers for supporting children's learning.

Information about the setting

The childminder registered in 2007. She lives with her husband and their four children, three of school age and one who is an adult. The childminder lives in Lower Clapton, within the London Borough of Hackney. The whole of the ground floor and the bathroom facilities on the first floor are used for childminding purposes. There is a garden for outdoor play. On the day of inspection there were no children in the early years age range present. The childminder also cares for older children. The childminder is registered on the Early Years Register, and both the compulsory and voluntary parts of the Childcare Register.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
