# The quality and standards of the early years provision

## The provision meets requirements

- The childminder has a suitable knowledge of the Early Years Foundation Stage and the correct procedures to follow to help protect children.
- The childminder has a sufficient knowledge of the learning and development requirements. This includes how she will plan, promote and assess children's development to help them achieve their next steps for learning.
- The childminder has a suitable understanding of how to manage children's behaviour appropriately and consistently.
- The childminder has a suitable understanding of how to promote children's health, safety and well-being in partnership with parents.
- The childminder provides suitable premises with safety measures in place to help keep children safe and secure.
- The childminder understands the need to evaluate her practice to make on-going improvements to children's care and learning.

#### Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary part of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## **Inspection activities**

- The inspector discussed the childminder's knowledge of the Early Years Foundation Stage requirements.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at the documents the childminder will use when caring for children and discussed her policies.
- The inspector looked at the space in which children will be cared for and the resources they will use.

## Information about the setting

The childminder registered in 1989. She lives with her husband in the village of Sandford Orcas, near Sherborne, Dorset. The whole of the ground floor is used for childminding, which includes a dedicated play room, lounge and kitchen, with toilet and rest facilities provided on the first floor. There is an enclosed garden area available for outdoor play. The childminder is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. The childminder currently has no children on roll.

#### Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
