The quality and standards of the early years provision

The provision does not meet requirements

- The provider has not informed Ofsted of the change in manager. This is an offence. It relates to the Childcare Register too, which is not met. Providers are required to inform Ofsted of such a change within 14 days. At the time of the inspection, Ofsted had not been notified of either the current manager, or the previous manager, for the out-of-school club.
- The provider does not ensure that all records required for inspection are readily available and accessible for inspection.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector talked with a staff member of the after-school-club, and held meetings with the management team.
- The inspector sampled the out-of-school club's documentation.
- The inspector read and took account of the club's self-evaluation form.
- The inspector viewed the premises and resources available for children's use.

Information about the setting

Aktiva Camps at Laurel Lane registered in 2014 and is one of 15 play schemes run by Aktiva Camps Limited. The after-school-club located at Laurel Lane Primary School is situated in West Drayton in the London Borough of Hillingdon. The club runs from 3.15pm to 6pm during term-time only. The club operates from several rooms, and uses the school's outdoor facilities. The club is registered on the Early Years Register, and the compulsory and voluntary parts of the Childcare Register. There are two staff working permanently with the children who both hold early years qualifications. At the time of the inspection the after-school-club had no early years children on roll.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure all records are easily accessible and available at inspection

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
