### This inspection

This home was judged good at the last full inspection. At this interim inspection Ofsted judge that it has **sustained effectiveness**.

At the full inspection in May 2014 the overall effectiveness of the home was judged to be good.

Since the full inspection the Registered Manager has left the organisation. The provider has appointed a new suitably qualified and experienced manager. The manager has submitted her application and is awaiting checks from the Disclosure and Barring Service to proceed with her application. The new manager is providing leadership to the staff team and is implementing changes to ensure the home is run efficiently and effectively. The manager has addressed the one requirement which relates to notifying the host Local Authority when a young person moves into or out of the home, and has addressed one recommendation in relation to the supervision of staff made at the full inspection. The home has yet to ensure that the reports from the home's monthly independent visits carried out under Regulation 33 are sent to Ofsted. As such a requirement has been issued within this inspection.

Young people continue to enjoy a good quality of care from a caring staff team who feel supported by the new manager to carry out their role. Young people who are new to the home receive a warm welcome from the staff team and young people. Staff place the young people's safety and welfare at the centre of their practice. Young people report 'I like living here, the staff help me and are kind.' Parents report that staff greet them in a friendly and hospitable manner, and support them and their child to ensure contact is safe and enjoyable for all involved.

There are adequate staffing levels in the home to ensure activities which young people request and individual appointments with specialist mental health services can be facilitated as required. Staff are positive about working at the home and said they feel very well supported by the management team. Staff receive regular supervision and most have training relevant to the needs of the young people. A

shortfall has been identified in regards to one member of staff who has yet to complete the required National Vocational Qualification Level 3 despite commencing employment in May 2012. The staff team report they feel valued and involved in decisions and improvements that have recently been made in the home. These improvements include developing and improving relationships with partner agencies and stakeholders, improving consultation with young people, parents and professional bodies about the quality of care the home provides, implementing and improving systems within the home to ensure the three monthly reports under are completed consistently, and ensuring all relevant staff are nominated for relevant training so they can secure the required qualifications needed for their role.

Good recruitment practices are followed. The provider understands the importance of following up gaps in employment as appropriate and verifying references. This promotes a robust approach to the recruitment of staff and keeps young people safe from adults who may pose a risk to them.

Shortfalls identified at this inspection relate to Regulation 33 and Regulation 34 reports and staff qualifications. However, these do not impact on the safety and welfare of young people or the continued effectiveness of service delivery.

### Information about this children's home

The home is run by a privately owned company and is registered for up to five children or young people who have a learning disability or mental health disorder.
